- Legal assistance and legal protection insurance (LPI)

If you intend to take part in hazardous sports or activities or you will participate in competitive events, training sessions in other sports, you are advised to take out the **Sport Plusz*** add-on for additional coverage.

* **Sport Plusz:** With a Welcome to Hungary Top or Welcome to Hungary & Europe policy, you may also take out a Sport Plusz add-on for an additional premium corresponding to 50% of the basic premium to include coverage for your non-competitive participation in the following hazardous sports, provided that you are under 80 years of age: indoor climbing, rafting, white water rafting, canyoning, riverboarding (hydrospeed), mountain biking (except downhill), trials or BMX biking, free diving or scuba diving to a depth of 40 metres, jet skiing, waterskiing, wake boarding, paragliding/parasailing over water when attached to a speedboat, rides on banana boats, air chairs, other inflatable boats towed by a speedboat, hunting, snowmobiling, (three or four-wheeled) quad biking, kite surfing, surfing, windsurfing, sailing, sea kayaking (coastal waters only - up to 1 km from the coast), horse riding, winter sports, rock climbing and mountaineering, snow shoe trekking. In respect of insured persons under the age of 70, you may pay the additional premium of the Sport Plusz add-on to include coverage for participation in competitive events in sports which are not hazardous sports or winter sports.

Winter sports: skiing, snowboarding, sledding, ice skating, snowmobiling, snowrafting.

** **Europe** – the following countries within geographical Europe: Albania, Andorra, Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Czech Republic, Denmark, United Kingdom, Finland, France, Greece, the Netherlands, Croatia, Ireland, Iceland, Kosovo, Poland, Liechtenstein, Luxembourg, Macedonia, Malta, Monaco, Montenegro, Germany, Norway, Italy, Portugal, Romania, San Marino, Spain (including the Canary Islands), Switzerland, Sweden, Serbia, Slovakia, Slovenia, Vatican City; Cyprus, Turkey.

Important Information

Insured may be any natural person under the age of 80

- who is not a Hungarian citizen
- whose permanent home address is not in Hungary, and
- who is covered under the statutory health insurance scheme in his/her country of residence or has comprehensive private health insurance, or is otherwise eligible to covered health care.

The geographical area covered under the insurance policy does not include the country

- which the insured is a citizen of, or
- where the insured has his/her permanent home address,
- which the Foreign Ministry advise against all travel to (<http://konzuliszolgalat.kormany.hu/utazasra-nem-javasolt-tersegek>)

The insurance coverage shall commence no earlier than at 00:00 hours on the day after the insurance policy is taken out and the insurance premium is paid.

The insurance does not cover

- physical work
- treatment of existing medical conditions
- medical treatment without a medical emergency.
